

# St Michael's Accessibility plan 2023 - 2026

#### Ethos and aims

St Michael's Preparatory School ('the School') strives to be a fully inclusive and welcoming school and therefore aims to ensure that each and every pupil can participate fully in the life of the School.

# Definition of disability and scope of the plan

A child or young person is disabled if they have a physical or mental impairment which has a substantial and long-term adverse effect on their ability to carry out normal day-to-day activities (as defined by the Equality Act 2010). The School's Accessibility Plan contains relevant actions to:

- increase the extent to which disabled pupils can participate in the School's curriculum
- improve the School's physical environment for the purpose of increasing the extent to which disabled pupils are able to take advantage of education and benefits, facilities or services provided or offered by the School
- improve the delivery to disabled pupils of information which is readily accessible to pupils who are not disabled

# How the plan is constructed

The School has a disability policy review committee which consists of Vince Holden (Interim Head), Chris Lanyon (Bursar) and Florence Clayton (SENDCO) and may co-opt additional members whose expertise in any field would be of assistance.

# The committee's terms of reference are:

- 1. to review annually the School's policies, procedures and facilities as they are likely to affect pupils and prospective pupils who are disabled
- 2. to make recommendations with a view to improving the accessibility of its education in many aspects to pupils or prospective pupils with disabilities by means of reasonable adjustments and by planning for the future
- 3. to review the School's SEND policy



- 4. to prepare the School's accessibility plan
- 5. to review such plans and policies as necessary and at least on an annual basis

The School's disability policy review committee has been central to the drawing up of the School's plan. They have considered the following when developing and reviewing the plan:

- Admissions
- Attainment
- Attendance
- Exclusions
- Education
- Extra-curricular activities
- Governing body representation
- Physical school environment
- Selection and recruitment of staff
- Sporting education and activities
- Staff training
- Welfare
